The Wireless Zone® Chatterspot Buyout Contest Official Rules

PARTICIPATION CONSTITUES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES AND PARTICIPANT'S AGREEMENT TO ABIDE BY ALL TERMS, CONDITIONS, RESTRICTIONS, LIMITATIONS, CODES OF CONDUCT AND LAWS APPLICABLE TO THE CONTEST.

- I. CONTEST ENTRY PERIOD: The "Wireless Zone® Chatterspot Buyout Contest (the "Contest") begins Monday April 1, 2021 (the "Opening") and ends December 31, 2021 (the "Closing") (collectively the "Contest Period"). All eligible Chatterspot sign-ups within the Contest Period will earn an entry into the drawing as described herein.
- II. ELIGIBILITY: The Contest is open only to: (i) Wireless Zone® customers who enroll in Chatterspot by responding "Yes" to an SMS text invitation, (ii) Wireless Zone® customers who enroll in Chatterspot by texting "ZONE" to the prescribed number, (iii) Wireless Zone® customers who enroll in Chatterspot via text, email or online opt-in, (iv) Wireless Zone® customers who are Chatterspot enrollees prior to the beginning of the Contest Period who request an entry from any Wireless Zone® franchise location (collectively under subsections (i)-(iv) "Eligible Customers") and (v) employees of Wireless Zone® franchisees who are active associates at Wireless Zone® franchised retail locations who are assigned to the invoice of an Eligible Customer entered into the contest under sections (i) to (iii) above ("Eligible Associates"). Eligible Customers must be enrolled in Chatterspot at the time of the drawing. The Contest is subject to all applicable federal, state, and local laws and regulations, and is void where prohibited by law. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- III. HOW TO PARTICIPATE: Eligible Customers who become eligible in a given calendar month (either through enrollment or a requested entry) will be entered into a single drawing. The drawing will be held on or before the 7th day of the subsequent calendar month (i.e., the Eligible Customers from April will be entered into a drawing that will take place on or before May 7). Each Eligible Customer will have a single entry in the drawing. Eligible Associates may be assigned to more than one Eligible Customer and therefore may be entered more than one time. The May 2021 drawing (selecting winners from April 2021 Eligible Customers) will select 5 winners. All other monthly drawings will select a single prize winner. All winners will be selected randomly via a drawing from all eligible entries.
- IV. PRIZES: Each Eligible Customer will receive one of the following prizes:
- (1) If the Eligible Customer has a device payment plan "DPP" with Verizon Wireless, Wireless Zone® will pay, in the form of a Verizon account credit, the outstanding amount of the DPP or \$1,000, whichever is less.
- (2) If the Eligible Customer does not have a DPP with Verizon Wireless, the winner may select either a \$500 Verizon account credit or a \$1,000 credit toward the purchase of an upgraded device on a DPP with Verizon Wireless.
- (3) If the Eligible Customer is not a Verizon Wireless subscriber, the winner will receive a \$1,000 credit toward the purchase of a wireless device on a DPP with Verizon Wireless at any Wireless Zone® retail location.
- (4) If the Eligible Customer has a DPP with an existing promotional credit from Verizon Wireless, Wireless Zone® will either pay, in the form of a Verizon account credit, the outstanding amount of the DPP or \$1,000, whichever is less; or the winner may select a \$500 account credit.

The Eligible Associate assigned to the Eligible Customer who is selected as the winner shall also be selected as a winner. No Eligible Associate may be selected as a winner more than once in a single drawing. The Eligible Associate will receive one of the following prizes:

- (1) If the Eligible Associate has a device payment plan "DPP" with Verizon Wireless, Wireless Zone® will pay, in the form of a Verizon account credit, the outstanding amount of the DPP or \$1,000, whichever is less.
- (2) If the Eligible Associate does not have a DPP with Verizon Wireless, the winner may select either a \$500 Verizon account credit or a \$1,000 credit toward the purchase of an upgraded device on a DPP with Verizon Wireless.
- (3) If the Eligible Associate is not a Verizon Wireless subscriber, the winner will receive a \$1,000 credit toward the purchase of a wireless device on a DPP with Verizon Wireless at any Wireless Zone® retail location.
- (4) If the Eligible Associate has a DPP with an existing promotional credit from Verizon Wireless, Wireless Zone® will either pay, in the form of a Verizon account credit, the outstanding amount of the DPP or \$1,000, whichever is less; or the winner may select a \$500 account credit.

Prizes must be redeemed within thirty (30) days of notification to the selected winner.

V. WINNER SELECTION, NOTIFICATION AND ODDS: Wireless Zone® will notify the winners of each drawing as they are selected. Odds of winning will depend on the total number of entries included in the drawing. After each Winner is verified, a written confirmation, a W-9 tax form and instructions for claiming or receiving the awarded prize will be emailed to the Winner. All W-9 forms must be completed and returned to Wireless Zone no later than the end of the calendar month in which the winner is selected.
